



**ARTICLES OF ORGANIZATION OF
WEISS & WEISS, LLC**

Article I

The name of the limited liability company ("Company") is WEISS & WEISS, LLC.

Article II

The mailing and street address of the Company's principal office is 2240 E. Annapolis Drive, Deltona, FL 32725. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by new members at the time the new members are admitted.


Article VII
