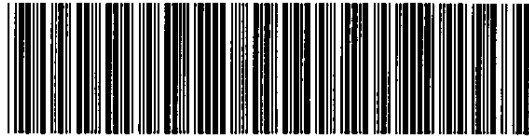

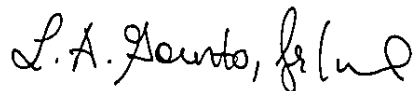

NAME

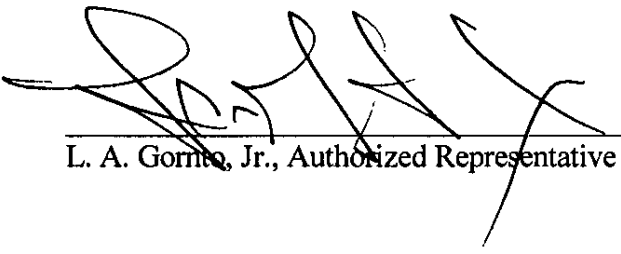

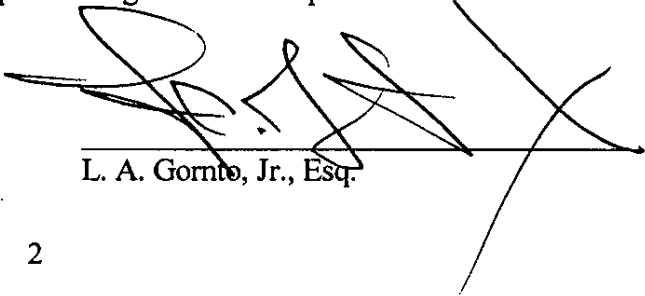
