**ARTICLES OF ORGANIZATION OF
SOUTHERN WASTE MANAGEMENT CONSULTANTS, LLC**

Article I

The name of the limited liability company ("Company") is SOUTHERN WASTE MANAGEMENT CONSULTANTS, LLC.

Article II

The mailing address of the Company is Post Office Box 862, Maywood, New Jersey 07607-0862 and the street address of the Company's principal office is 13304 Stonebrook Drive, Sanford, Florida 32771. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.

Article IV

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company as provided in the Company's Operating Agreement.

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company is vested entirely in the Members and any such adoption, alteration, amendment or repeal must be done by unanimous written consent of the Members.


