ARTICLES OF ORGANIZATION OF GIBRALTAR NETWORK LLC

Pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State, the following are the Articles of Organization for Gibraltar Network LLC (the "Company"):
