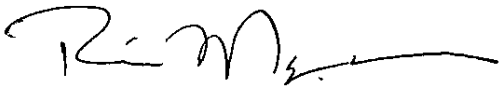

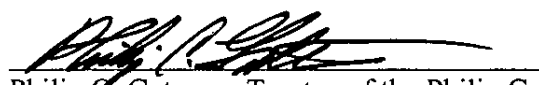
ARTICLE III-REGISTERED OFFICE AND AGENT
