

FIRST AMENDMENT to ARTICLES OF ORGANIZATION OF STEELE CREEK ASSOCIATES, LLC

Pursuant to the terms of the Articles of Organization of Steele Creek Associates. LLC, a Florida limited liability company, dated August 20, 2007, the undersigned, being all of the Managing Members of Steele Creek Associates, LLC (the "Company"), do hereby certify that the following is the First Amendment to the Articles of Organization of Steele Creek Associates, LLC.

Section I. Recitals

The Managing Members of the Company filed the Articles of Organization of the Company on August 20, 2007 ("Articles of Organization"). The purpose of this First Amendment to the Articles of Organization as amended is to reflect the transfer by Randall A. Rauch as Managing Member of his entire 25% Interest as a Member in Steele Creek Associates, LLC, to Frederic Stein, as Managing Member in Steele Creek Associates, LLC, and the transfer by Michael Rauch as Managing Member of his entire 25% interest as a Member in Steele Creek Associates, LLC, to Frederic Stein, as Managing Member in Steele Creek Associates, LLC, under the Articles of Organization. Following this Transfer, the collective interests of both Randall A. Rauch and Michael Rauch in Steele Creek Associates, LLC, will decline from 50% to 0.00% and the interest of Frederic Stein, in Steele Creek Associates, LLC, will increase from 25% to 75%.

Section 2: Modification

Amendment. The Articles of Organization of Steele Creek Associates, LLC, are hereby amended by deleting the first sentence of Article VI Capital Contributions from the Articles of Organization and substituting in its place the following sentence:

"Capital contributions, if any, shall be paid to the limited liability company by the members in such shares as to create the following ownership interests: Frederic Stein 75% and Jefferson Weaver 25%."

Except for the amendment stated above in Section 2 regarding the change in ownership interests, the terms and conditions of the Articles of Organization as amended remain in full force and effect.
