



ARTICLES OF ORGANIZATION

- Duration. The Company's existence shall be effective as of August 17, 2007 and shall thereafter be perpetual.
- Purpose. The Company is organized for the purpose of transacting all lawful 3. activities and businesses that may be conducted by a limited liability company under the laws of Florida.
