**ARTICLE IX - MANAGEMENT**

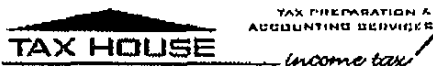


**ARTICLE XII - DISSOLUTION**


