**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION OF
COSOURCE, LLC.**

The undersigned subscriber to these Amended and Restated Articles of Organization, being a natural person competent to contract as such under the laws of the State of Florida, and being the Manager specifically elected and directed by the Operating Agreement, hereby amends and restates the Articles of Organization filed with the Florida Secretary of State on August 24, 2007 and assigned document number L07000087044, in their entirety, pursuant to Section 608.411 of the Florida Statutes as follows:

ARTICLE I

Name. The name of the limited liability company shall be COSOURCE, LLC ("Company").

ARTICLE II

Address. The mailing address and street address of the principal office of the Company shall be 353 Interstate Boulevard, Sarasota, FL 34240.

ARTICLE III

Duration. The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in the operating agreement of the Company.

ARTICLE IV

Initial Registered Office and Agent. The street address of the initial registered office of the Company is 111 North Orange Avenue, Suite 1200, Orlando, FL 32801 and the name of the initial registered agent of the Company at that address is THOMAS P. MORAN.

ARTICLE V

Management. The Company shall be managed by a manager or managers in accordance with an operating agreement adopted by the members for the management of the business and affairs of the Company.
