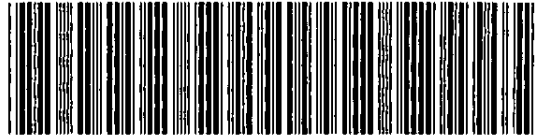



Pursuant to Fla. Stat. Chapter 608, the Florida Limited Liability Company Act and Fla. Stat. Chapter 621, the Professional Service Corporation and Limited Liability Company Act, in particular, Fla. Stat. §608.411, Dennis Chen, PL, a Florida professional limited liability company ("Company") with Articles of Organization filed on August 27, 2007, with assigned document number L07000087349, hereby amends the Articles of Organization of Dennis Chen, PL ("Articles") and adopts such amendment in this *Articles of Amendment to the Articles of Organization of Dennis Chen PL*:

**ARTICLE IV - MANAGEMENT**


