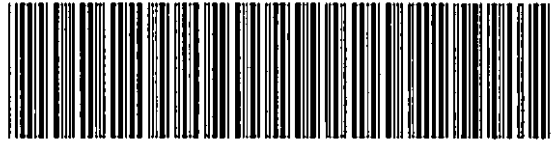

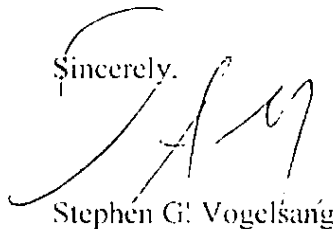

The Company shall be manager-managed in accordance with the Agreement.

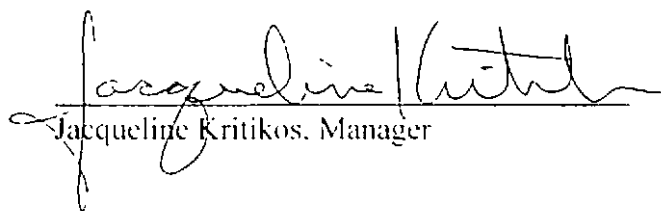

### Membership Certificates

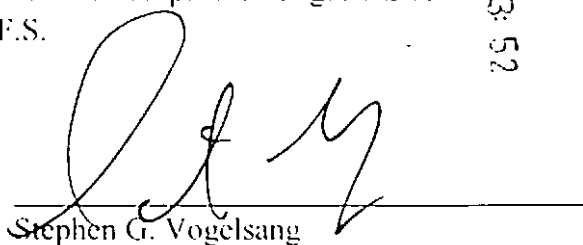
