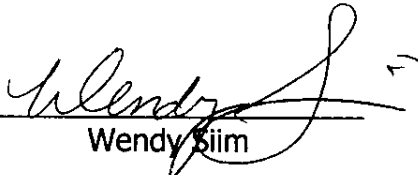

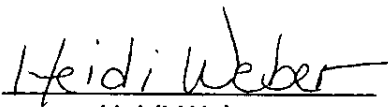
Agreement to dissolve LLC:
