## **ARTICLES OF ORGANIZATION** OF PIZZAZZ INTERIORS II, LLC,

a Florida Limited Liability Company

OTHER PRINGS The undersigned, being the initial members of a limited liability company to be organized under the Florida Limited Liability Company Act, adopt and submit the following Articles Organization for such limited liability company:

#### ARTICLE I NAME
