**ARTICLES OF ORGANIZATION
OF
EVAN TRANSPORT LLC**

ARTICLE I

Name

The name of the limited liability company is Evan Transport LLC (hereinafter called the "Company").

ARTICLE II

Duration

The existence of the Company shall be perpetual.

ARTICLE III

Principal Office

The mailing address and the street address of the principal office of the Company is 9724 S.W. 156th Ct., Miami, Florida 33196.

ARTICLE IV

Initial Registered Office and Registered Agent

**Restrictions on Membership and

Upon the occurrence of any event that terminates the continued membership of a member in the Company, the remaining members shall have the right to continue the business upon consent of the members owning a majority of the interests in the Company.
