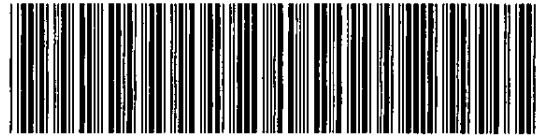

**FIRST**

**SECOND**

This amendment is being submitted solely to correct a scrivener's error in the original Articles of Organization that were filed. Existing Article IV of the Articles of Organization entitled *Management*, is hereby deleted in its entirety, and a new Article IV is substituted in lieu thereof, which article shall read as follows:

**"ARTICLE IV  
MANAGEMENT**

The limited liability company shall be managed by the members in accordance with operating agreement adopted by the members for the management of the business and affairs of the Company. These operating agreement may contain any provisions for the regulation and management of the affairs of the limited liability company not inconsistent with law or these Articles of Organization. 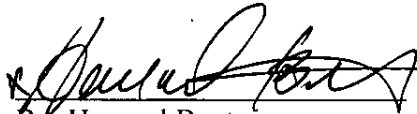

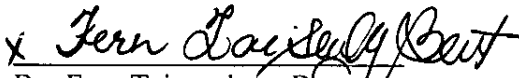
