**RESTATEMENT OF ARTICLES OF ORGANIZATION

The undersigned, being authorized to execute and file this Restatement of Articles of Organization, hereby certifies that:

ARTICLE I – Name and Original Articles:

The name of this limited liability company (hereinafter referred to as the "Company") is "Lee House Pensacola, LLC". The original Articles of Organization for the Company were filed on August 28, 2007.

ARTICLE II - Address:

The mailing address and street address of the principal office of the Company is 212 Alcaniz Street, Pensacola, FL 32502.

ARTICLE III - Duration:

The period of duration for the Company is perpetual.

ARTICLE VIII - Registered Agent and Office:




