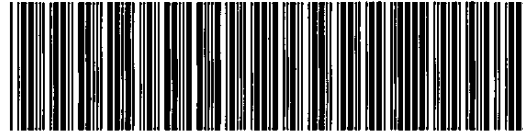

ARTICLE I - Name:

The name of the Limited Liability Company is: **FEDDEV SF, LLC** (hereinafter the "Company").
