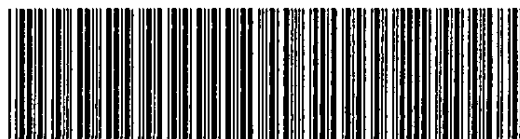

**ORDER GRANTING LAKE CITY SURGERY CENTER, LLC'S UNOPPOSED
MOTION FOR ENTRY OF ORDER LAYING ASIDE DISSOLUTION,
OR IN THE ALTERNATIVE, JUDGMENT RENDERING THE
ACTION OF FORMER MANAGER/MEMBER VOID**

THIS MATTER came before the Court on Lake City Surgery Center, LLC's Unopposed Motion for Entry of Order Laying Aside Dissolution, or in the Alternative, Judgment Rendering the Action of Former Manager/Member Void. After notice and having considered the matters properly before it, it is:

ORDERED AND ADJUDGED, as follows:

1. Lake City Surgery Center, LLC's Motion is **GRANTED**.
2. The Court finds that the "Articles of Dissolution" for Lake City Surgery Center, LLC, filed on April 5, 2010, by and through Joseph W. Deerin and Richard Welkowitz, as principles of Sarno Road Associates, LLC (Document L07000088906) were filed under a mistake of fact and were without proper authority. The Court finds the Articles of Dissolution a nullity and *void ab initio*. The Court finds that the Articles of Dissolution are of no force and effect.

3. The Court recognizes that Lake City Surgery Center, LLC will present this Order to the Secretary of State for purposes of seeking the reinstatement of Lake City Surgery Center, LLC.
