**ARTICLES OF ORGANIZATION  
OF  
PURITAN ENTERPRISES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be Puritan Enterprises, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be: 160 Plantation Circle South, Ponte Vedra Beach, Florida, 32082.

**ARTICLE II**

**DURATION**

**ARTICLE VI**

**ADMISSION AND WITHDRAWAL OF MEMBERS**

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company.

**ARTICLE VII**

**TERMINATION OF EXISTENCE**



**ARTICLE VIII**

**MANAGER**


