ARTICLES OF ORGANIZATION

OF

360 SEVILLA ENTERPRISES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be 360 Sevilla Enterprises, TC (The "Company"). The mailing and street address of the principal office of the Company Florida shall be: 160 Plantation Circle South, Ponte Vedra Beach, Florida 32082.

ARTICLE II

DURATION

The Company's existence shall commence on the date these Articles of Organization are filed by the Florida Department of State and shall continue perpetually or until dissolved in accordance with these Articles of Organization adopted by the members.

Admission and Withdrawal of Members

No additional members shall be admitted to the Company except with the unanimous written consent of the members of the Company.

ARTICLE VII

TERMINATION OF EXISTENCE

The Company shall not be dissolved upon the occurrence of any event that terminates the strong of the continued membership of a member in the Company, provided there is at least one remaining the strong member. The Company shall be terminated and dissolved upon the consent of all of the strong members.

ARTICLE VIII

MANAGER
