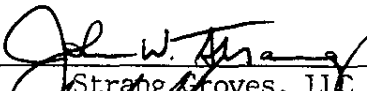
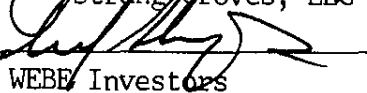

December 11, 2008

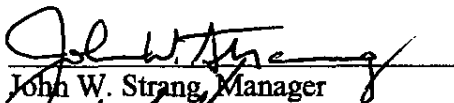
The final meeting of Block L., LLC was held December 11, 2008 at the offices of the corporation.
