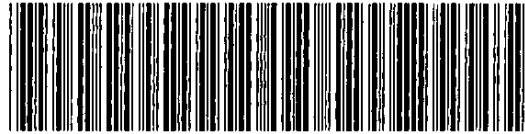

ARTICLES OF ORGANIZATION
FOR
