**ARTICLES OF ORGANIZATION

### **OPERATING AGREEMENT**

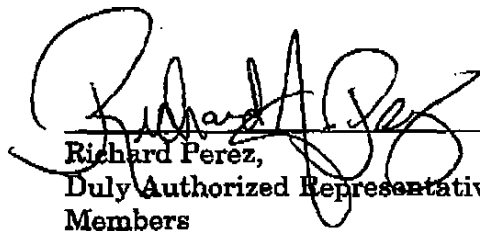
