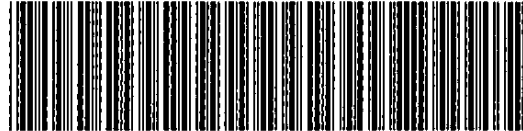

**Admission of Additional Members**


Members shall have the right to admit additional members as provided by the Florida Limited Liability Company Act by a vote of members owning a majority of the Company's voting units.
