ARTICLES OF ORGANIZATION OF TBDRIN, LLC

The undersigned, acting as the organizing Member of this limited liability company pursuant to Chapter 608 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for said limited liability company:

ARTICLE I - NAME OF LIMITED LIABILITY COMPANY

The name of this limited liability company shall be TBDRIN, LLC.

ARTICLE II - PERIOD OF DURATION

The period of duration of this limited liability company commenced on September 5, 2007, and shall continue until dissolved pursuant to Chapter 608 of the Florida Statutes.

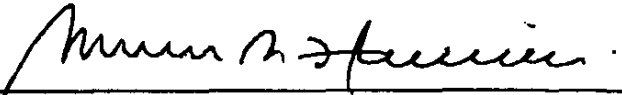

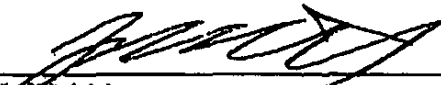
