The name of the limited liability company hereby formed under the Act is Brumos Racing, LLC.

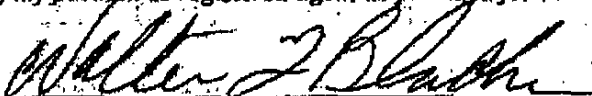

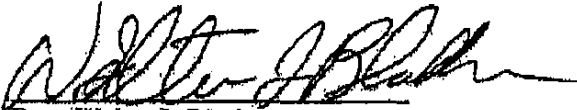
