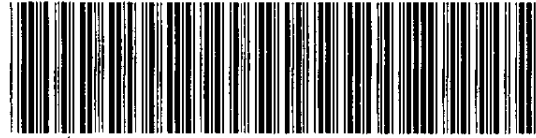

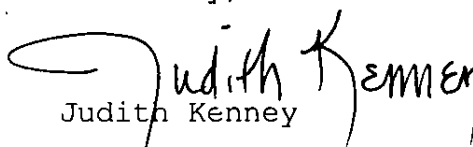

### **RESTRICTIONS ON MEMBERSHIP AND RIGHT TO CONTINUE AFTER WITHDRAWAL OF A MEMBER**

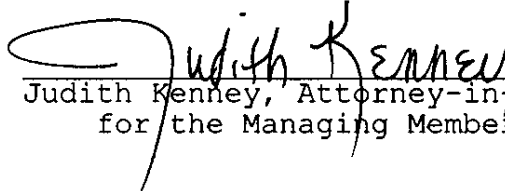
The managing members shall have the right to admit new members. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

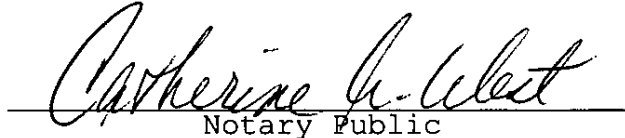

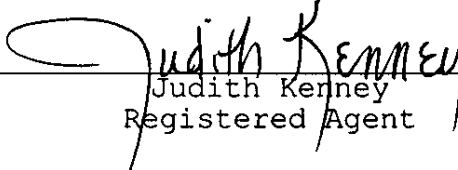
