

ARTICLES OF ORGANIZATION OF ALLSTATE VILLAGES INSURANCE AGENCY, LLC

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. NAME.

The name of the Limited Liability Company is: Allstate Villages Insurance Agency, LLC.
