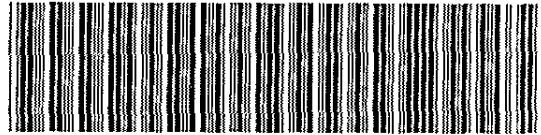

ARTICLE I.
NAME AND PRINCIPAL OFFICE

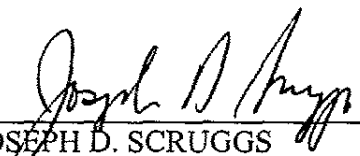

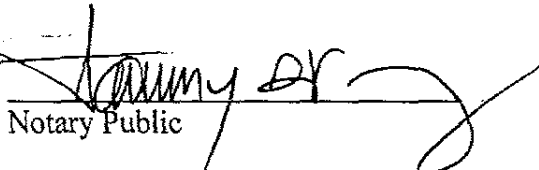

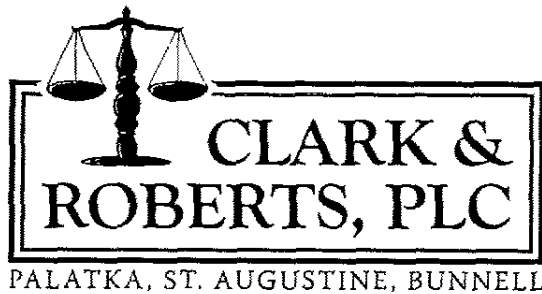
