ARTICLES OF ORGANIZATION OF HAWKINS COVE, L.L.C.

The undersigned member, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608 (Limited Liability Companies), hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- Name
