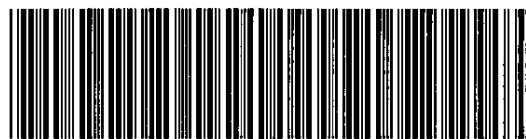

Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

**FIRST:** The name and address of this Company is **TRINOVA MARKETING LLC**, 2301 Hannah Way South, Dunedin, Florida 34698.

**SECOND:** The date of the adoption of these Articles of Dissolution is 17 July 2008.

**THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members.
