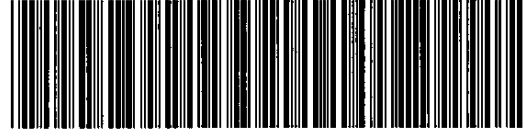

Initial Member

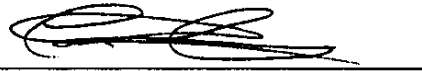

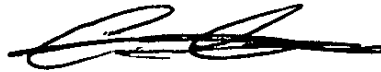
