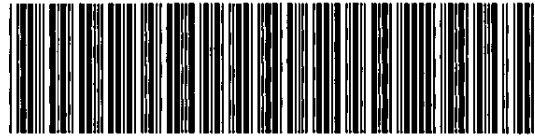


ARTICLE VI


