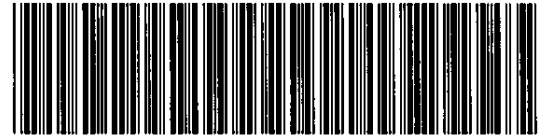

ARTICLES OF ORGANIZATION  
OF  
ULMERTON INDUSTRIAL MART II, LLC

The undersigned, desiring to form a limited liability company under the provisions of Sections 608.401 *et seq.*, Florida Limited Liability Company Act, as amended, hereby sets forth the following:

Article I. Name. The name of the Limited Liability Company is ULMERTON INDUSTRIAL MART II, LLC.

Article II. Principal Office. The mailing address and the street address of the principal office of the Limited Liability Company is 9380 Ulmerton Road, Clearwater, Florida 33771.

Article III. Registered Office and Agent. 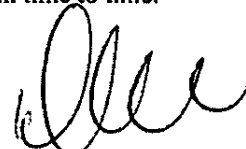

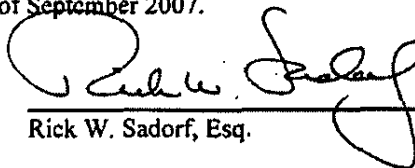
