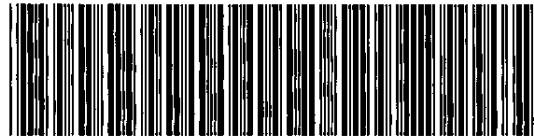

The undersigned, pursuant to the provisions of §608.411 of the Florida Limited Liability Company Act, desiring to amend and to restate, in its entirety, the original Articles of Organization of UNITED TELERADIOLOGY SERVICES, LLC, filed with the Florida Department of State on September 13, 2007, hereby adopts such Amended and Restated Articles of Organization in the form set forth below:

ARTICLE I - NAME
