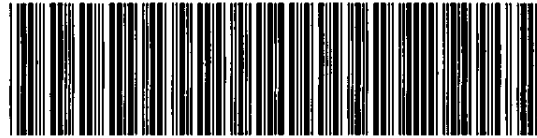


To correct the name of the managing member. Currently the
