



ARTICLES OF ORGANIZATION

FOR

JONJEN ENTERPRISES, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a Limited Liability Company under the laws of the State of Florida do hereby set forth the following:

ARTICLE ONE - NAME
