MEMBERSHIP

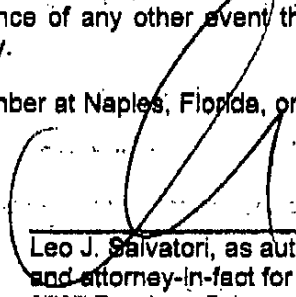
