**ARTICLES OF ORGANIZATION

ARTICLE I -- NAME

ARTICLE V -- CAPITAL CONTRIBUTIONS

The Regulations and the Operating Agreement, if any, shall determine the manner in which such the Manager(s) are elected and appointed, and may contain any provisions for the regulation and management of the affairs of the company not inconsistent with the law or these Articles of Organization. ARTICLE IX -- TERMINATION OF EXISTENCE


The Company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued


