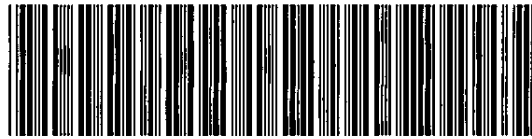

**ARTICLES OF ORGANIZATION
OF
TRAVIS WOODS FLORIDA, L.L.C.
A Florida Limited Liability Company**

THE UNDERSIGNED being the duly authorized representative of the initial members of a limited liability company to be organized under the laws of the State of Florida, pursuant to Chapter 608, Florida Statutes, and certifies they intend to form and declare that the following Articles of Organization shall be the Charter and authority for the conduct of business of such limited liability company.

**ARTICLE I
NAME**

The name of the Florida limited liability company (the "Company") shall be "TRAVIS WOODS FLORIDA, L.L.C.".

**ARTICLE II
ADDRESS**

The mailing and street address of the Company's principal office is:

**ARTICLE III
REGISTERED AGENT AND OFFICE**

The name of the Company's initial registered agent in Florida is Bradley Donnelly and the address of the Company's registered agent in Florida is c/o TRAVIS WOODS FLORIDA, L.L.C., 216 Henley Drive, Naples, Florida, 34104.

**ARTICLE IV
MEMBER MANAGEMENT**

The Company is to be managed by the members. The names and address of the initial Member Manager is Bradley Donnelly, whose address is 216 Henley Drive, Naples, Florida 34014.

**ARTICLE V
DURATION AND CONTINUATION OF BUSINESS OPERATIONS**

The duration for the Company is perpetual. Upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or any other event that would terminate the continued membership of a member in the Company, the remaining members shall have the right to continue the business of the Company as provided in the Operating Agreement and Regulations.

ARTICLE VI
PURPOSES

The general nature of the business or businesses to be transacted and which the Company is authorized to transact shall be as follows:

A. To engage in any activity or business authorized under the Florida Statutes including, but not limited to, the investment, purchase, sale, manufacture, design, copyright, license, trademark, ownership, operation, and management of personal and commercial safety and survival kits and all matters incidental and related thereto.

B. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the State of Illinois, and to do any and all things herein set forth to the same extend as a natural person might or could do.

ARTICLE VII
ADMISSION OF NEW MEMBERS

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of the contribution by new members at the time the new members are admitted.

ARTICLE VIII
ADOPTION OF OPERATING AGREEMENT AND REGULATIONS

The initial Operating Agreement and Regulations of the Company shall be adopted by its initial members. The Operating Agreement and Regulations may contain any provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

ARTICLE IX
TRANSFERABILITY OF MEMBER'S INTEREST

A member's interest in the Company shall not be transferred unless the transfer is approved by the members in accordance with the Company's Operating Agreement and Regulations.

IN WITNESS WHEREOF, the undersigned being the duly authorized representative and Member Manager of the Company, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, has executed these Articles of Organization as of this 11th day of September, 2007.
