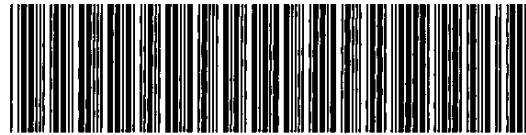

**Article 1. Name of Company**

The name of the Company is BZR STEEL, LLC

**Article 4. Registered Agent, Address and Registered Agent's Signature**


Section 4.1. Name and Address of Registered Agent

Section 4.2. Status of Registered Agent

The registered agent is an individual resident of Florida.

**Article 5. Duration**

The period of duration of BZR STEEL, LLC is perpetual, unless otherwise agreed to by written unanimous consent of the members.

**Article 6. Purpose**

BZR STEEL, LLC has been formed for the following purposes: steel fabrication or to promote any lawful business or purpose permitted by the laws of Florida.

**Article 7. Manager or Managing Member**

The Company is to be managed by one or more of the member(s) as may be provided for in the Operating Agreement and shall therefore be a Member-Managed LLC. The name and address of each Manager ("MGR") or Managing Member ("MGRM") is as follows:

1) Mr. Benjamin King, Managing Member (MGRM) (33.3% Member), 10001 N Palafox Rd., lot 6, Pensacola, FL 32534

2) Mr. Zahid Khan, Managing Member (MGRM) (33.3% Member), 5560 Willard Norris Rd., Milton, FL 32570.

3) Mr. Rodney Melvin, Managing Member (MGRM) (33.3% Member), 33012 Juniper Rd., Seminole, AL 36574.

#### **Article 8. Member' Authority to Bind Company**

To be able to bind the company to any debt, mortgage, lien, encumbrance, contract, lease, credit, or the like, whereby the member's signature is requested or required and the company is financially obligated to pay a third party or the third party is obligated to pay a member or other third party out of the company's funds, there shall be in all cases the signature of at least two (2) members. A member acting alone in said matters is acting ultra vires and is not authorized to bind the company to said actions.

#### **Article 9. Admissions of New Members**

Member(s) of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of contributions by the new members at the time the new members are admitted.

#### **Article 10. Indemnification**

Subject to Article 8 below, the Company shall, to the fullest extent permitted by Florida Statutes, section 608.4229 (Florida Limited Liability Act), as amended from time to time, indemnify all persons whom it may indemnify pursuant thereto. The indemnification provided by this Article shall not limit or exclude any rights, indemnities, or limitations of liabilities to which any person may be entitled, whether as a matter of law, under the Operating Agreement of the Company, by other agreement or otherwise, except as specifically limited in these Articles.

#### **Article 11. Subordination of Indemnification Provisions**

Notwithstanding any provision hereof to the contrary, any indemnification claim against the Company arising under these Articles, the Operating Agreement, or the laws of the State of Florida shall be fully subordinate to any obligations of the Company arising under the Security Instrument or any other Loan Document (as defined in the Security Instrument), and shall only constitute a claim against the Company to the extent of, and shall be paid by the Company in monthly installments only from, the excess of net operating income for any month over all amounts then due under the Security Instrument and the other Loan Documents.

#### **Article 12. Effect of Death, Bankruptcy, Dissolution**

The bankruptcy, death, dissolution, liquidation, termination or adjudication of incompetence of a member shall not cause the termination or dissolution of the Company, and the business of the Company shall continue. Upon any such occurrence, the trustee, receiver, executor, administrator, committee, guardian or conservator of such member shall have all the rights of such member for the purposes of settling or managing its estate or property, subject to satisfying conditions precedent to the admission of such assignee as a substitute member. The transfer by such trustee, receiver, executor, administrator, committee, guardian, or conservator of any Company interest shall be subject to all the restrictions hereunder or Operating Agreement to which such transfer would have been subject if such transfer had

been made by such bankrupt, deceased, dissolved, liquidated, terminated or incompetent member.

#### Article 13. Title to Company Property

All property owned by the Company shall be owned by the Company as an entity and insofar as permitted by applicable law, no member shall have any ownership interest in any Company property in its individual name or right, and each member's interest in the Company shall be personal property for all purposes.

#### Article 14. Tax Status




BZR STEEL, LLC is intended to be treated as an "S Corporation" for purposes of federal income taxation.
