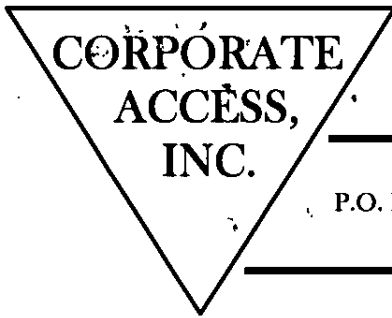


ARTICLES OF DISSOLUTION
