EXISTENCE**

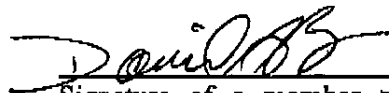
The date when the Company's existence will commence is September 17, 2007, in accordance with Section 608.409(1) of the Act.
