ARTICLES OF ORGANIZATION

OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be KB SUPPLIES LLC, ("Company").

ARTICLE 2 - ADDRESS

<u>ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT</u>

ARTICLE 7 - ADMISSION OF NEW MEMBERS

All references in these Articles of Organization to "member", "manager", "employee" and "agent" shall include the heirs restarts. executors, administrators and personal representatives of such persons.
