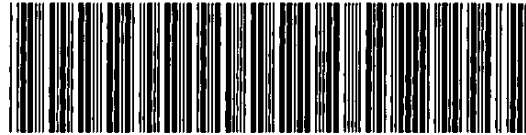


**ARTICLE VI - Miscellaneous**
