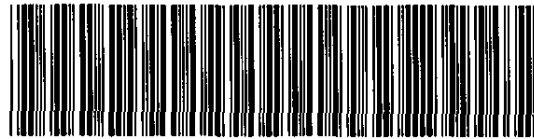

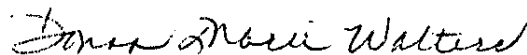

The undersigned, pursuant to the provisions of Chapter 608, Florida Statutes, provides the following information for the purpose of amending the Articles of Organization of **BBPI GOVERNORS LLC**, which was formed under the laws of the State of Florida pursuant to Articles of Organization originally filed with the Department of State on September 20, 2007, and assigned document number L07000096101.

1. Article 1 of the Articles of Organization is amended to read:

**ARTICLE 1.
Name**

*The name of the Limited Liability Company is **BBPI Uptown Station LLC**.*

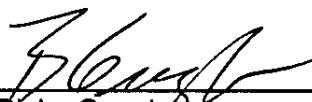
