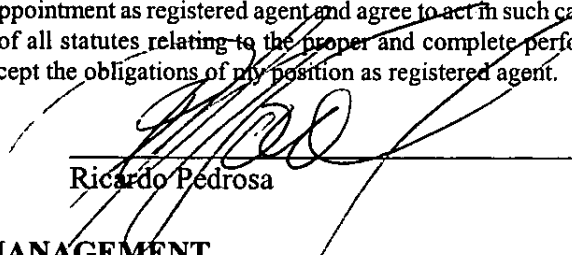
ARTICLE IV PRINCIPAL PLACE OF BUSINESS

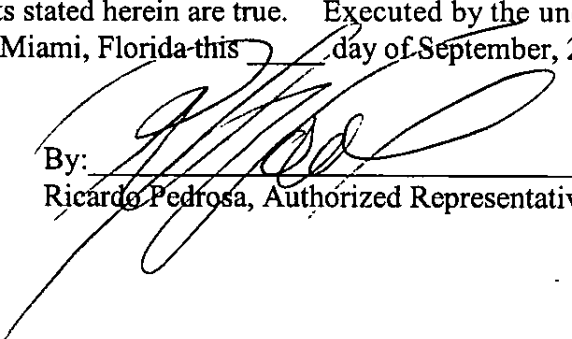
