ARTICLE I
NAME

The name of this Limited Liability Company shall be **LOSTART, LLC**.

ARTICLE II
DURATION

The right, if given, of the remaining members to admit additional members and the terms and conditions of the admissions shall be as provided in the Company's Operating Agreement.

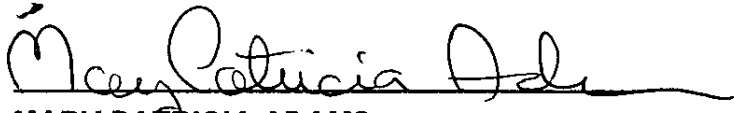
ARTICLE VIII

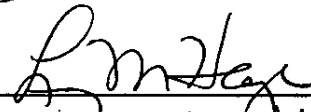

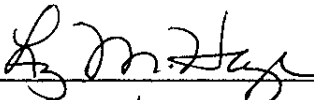
