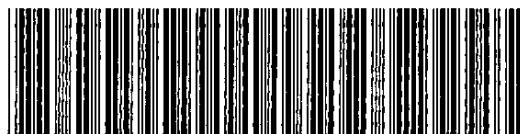



ARTICLE IV




