The name of the limited liability company is: Tampa Bay Real Estate Investment Company, LLC

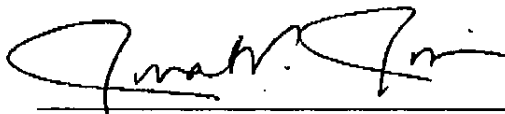
ARTICLE II. ADDRESS

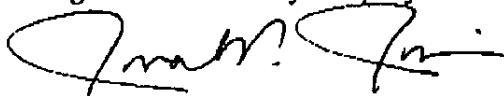
